## Conference purpose and goals

Providing treatment services to youth in residential foster care and residential juvenile justice programs presents a multitude of opportunities and challenges to transform lives. Youth enter residential treatment due to experiences of abuse, neglect or adjudication, often involving traumatic circumstances, emotional and educational struggles, and risky and/or dangerous behaviors. Whether youth are in a short-term assessment, detention facility or a residential treatment program, personnel have the responsibility to assure safety and security for the youth and provide clinical interventions that will positively impact the trajectory of their lives.

Goals of this conference are to offer treatment and practice strategies and tools for residential programs to:

- ◆ Align residential practices with desired outcomes for youth served.
- ◆ Address mental and behavioral health needs of youth in residential settings.
- ◆ Incorporate youth-guided family-driven principles of care into service provision.
- ◆ Engage and support families with complex challenges to assure a youth's timely and successful return to community and home, when appropriate and safe.

## Meet our keynote presenter



**Jody Levison-Johnson**, LCSW-C, is assistant vice president of practice improvement for the National Council for Behavioral Health and is a consultant for the national

Building Bridges Initiative (BBI). She is a licensed clinical social worker and has over 20 years of child, adolescent and family behavioral health experience.

Prior to joining the National Council, Levison-Johnson served as the chief clinical officer for Choices Coordinated Care Solutions, a care management organization that provides wraparound and care coordination services to youth in four states and the District of Columbia, where she was responsible for all program operations as well as service and business development activities. She served as the deputy assistant secretary of the Louisiana Office of Behavioral Health from 2011 to 2014 where she was responsible for clinical oversight and management of publicly funded behavioral health services for adults and children, including the statewide public sector managed care efforts.

Levison-Johnson has also served as vice president of Coordinated Care Services, Inc. (CCSI), a nonprofit management and consulting services organization where she led all child and family and adult service quality, system development and evaluation activities. During her tenure at CCSI, Levison-Johnson led Monroe County's system of care implementation and provided technical assistance to communities across the country to support human service system improvements. She has extensive knowledge in the areas of child and family human services, public sector behavioral health, wraparound and care coordination, residential reform, and managed care implementation and operations.

## Meet our presenters



**Jim Dalton,** PsyD, licensed child psychologist, is the president and CEO for Damar Services, Inc. in Indianapolis, IN. Dr. Dalton has spent more than

27 years in the field of child and adolescent behavioral health in a variety of different roles, including clinical consultant, evaluator, researcher and administrator. He was appointed by Indiana's Governor as the child psychologist representative for the Indiana Commission on Abused and Neglected Children. He is published in the areas of children's residential treatment best practices, reduction of restraint and seclusion events, treating trauma in youth with developmental disabilities, and organizational change to achieve long-term outcomes for youth with intensive needs and their families.

Dr. Dalton is the founder of Indiana's credentialing and training authority (IN-AJSOP) for clinical, professional and direct care staff and foster parents working with children with sexual behavior problems and their families. He is the founder and superintendent of Indiana's first public charter school focused on the educational and behavioral needs of children with severe developmental and learning challenges. He is the founder and author of Indiana's Integrated Services Program (ISP), an alternative fiscal and clinical approach for youth in need of intensive services.

Dr. Dalton regularly speaks at local, state and national levels on innovation in child behavioral health care. Dr. Dalton completed his BA degree at Anderson University and his MA and doctoral degree at Spalding University in Louisville, KY. He completed his pre-doctoral internship and post-doctoral residency at the Ohio State University School of Medicine.



**Michael E. Johnson,** LMSW, CAAC, is a nationally recognized trainer and lecturer in the field of addictions. Over the years, he

has served the addictions field in many capacities: counselor, program director, consultant and trainer. He has developed a series of educational DVDs that are shown throughout the United States within residential AOD treatment settings, correctional institutions and prevention programs. He has worked as a consultant for the Michigan Department of Corrections, New York Department of Corrections, the Federal Bureau of Prisons as well as numerous drug courts throughout the country. He served as faculty for Eastern Kentucky University's Alcohol and Other Drug Studies for several years and has conducted classes at colleges and universities.

Johnson graduated from Wayne State University, earning a bachelor's degree in counselor education (1988) and his master's degree in social work (1994). He is a licensed social worker and a certified advanced addictions counselor in the State of Michigan and possesses a tenacity for learning which has not ceased. He enjoys reading, attending trainings and seminars and loves a lively debate on addiction-related topics, counseling techniques and skill building. Johnson believes that the education and need for training of counselors, therapists, social workers and psychologists never ceases.

Johnson is known for his provocative lecturing style relative to the field of counseling, addiction and recovery and those issues associated with human struggles that are often ignored but so much a part of being alive. He is engaging and notorious for including audience experiences in his presentations.



**Cole Williams** is the CEO and founder of "Son To A Father" and "Cole Speaks," which are programs that work to empower and

restore relationships between teens and their parents. He has developed curricula and workshops that explore the emotional terrain of parenting.

Cole Williams' journey—from growing up fatherless, to becoming a single teenage father, to reuniting with his biological father, to finally fostering and adopting fatherless sons—has provided the lessons he uses to illustrate the colors of parenting in the 21<sup>st</sup> century. He is a motivational speaker, fatherhood consultant, facilitator and, most importantly, a father.

Williams' most recent work has been dedicated to providing fatherhood training, support and materials for the Michigan Adolescent Pregnancy and Prevention Program (MI-APPP) as well as penetrating the culture of the Kent County Juvenile Detention Center, where he provides life skills and leadership development to incarcerated youth.

Cole Williams and his sons have developed a 12-week Fatherhood Workshop Series for incarcerated fathers in partnership with Criminal Justice Chaplaincy (CJC), an organization whose mission is to rebuild lives and restore hope for families and communities affected by the criminal justice system. Both Williams and CJC are working together to support fathers who will one day return home to children, families, and communities who will be awaiting their return.

Williams also provides an 8-week Parenting Educational Workshop Series for Parents who have family court involvement in the State of Michigan.

### **Working Through Adolescent Trauma**

Presenter **Michael Johnson, National Trainer and Lecturer in the Field of Addictions**

Working with adolescents who have experienced trauma, including alcohol and drug abuse, can be both a very rewarding and a very challenging experience. This session's focus is on young people whose acting-out or delinquent behaviors are compromising their well-being or capacity to develop. The goal is to provide practitioners with principles, strategies, and interventions that will promote good practice when working with this population.

Presenter **Cole Williams, CEO and founder of "Son To A Father" and "Cole Speaks"**

Motivational speaker Cole Williams will take you on an emotional rollercoaster as he shares and explores his transformation from a 16-year-old single father of a son born into foster care, to a direct care counselor for a residential program. Cole later became a foster and adoptive parent to seven sons where he had the privilege to provide a healing place for young men diagnosed with ADHD, PTSD, ODD, RAD and many other diagnoses. His story will take you through laughter and tears, and leave you with a sense of hope and purpose as agents of change for children and their families in treatment.

As a result of this session, you will:

- Understand how important having and using a self-care plan can be to positively impact the dyad between residential staff and youth in care.
- Know that your very presence can be a mirror for youth to view themselves and a window for them to see their future selves.
- Understand the importance and meaning of Resiliency, Empathy and Judgment (R.E.J.) and how each one can impact the relationship with a youth and their family.
